Keith Money made a motion and Fran Watson second to have the CAM Team move forward with letters of intent to lien on thirteen homes and start the foreclosure on two properties. None opposed motion carried.

Dion James stated that is why we have a violations tracker and those persons who do not comply will be receiving a letter.
