III. Management Company Update:

a. Current Financial Report

- **e. Solar Lights at entrance** Went over bids from Almsgiving (too high) and Johnny's Pro Cuts: board decided to hold off on adding solar lights for now.
- **f. Spring Planting & Irrigation** Reviewed Greenways quote for spring planting. Quote was higher than budget allowed for. Will request new quotes for maximum price of \$700 for exit side. Board approved Greenway to go ahead with mulch and asked that shrubs be cut a certain way now that Christmas lights are down to help the light shine on the deed restricted sign. Reviewed Greenways quote for irrigation. Board not happy that they just paid to have it fixed and non-working rain sensor wasn't noticed while they were out there before. Board requested 3 quotes from irrigation companies.

g. 2019 Projects – Board is thinking of changing up the mailboxes to possibly make residents have the same one, make residents with leaning or broken mailboxes missing addresses fix theirs or just making sure opening of mailbox is at least 6" from curb. Will check with county for any ordinances.
